Youth Success Story



One of the primary goals of Tri County CMO is to connect youth and their families with supports in their communities. This can become challenging in situations where youth are too anxious to leave their homes to get to school, medical appointments, or even just to accompany their families while running errands. Matthew and his family were able to navigate around this barrier with assistance from their team, including care manager Yahaira Gonzalez and the staff at Allegro School. When Yahaira first met their family, Matthew was struggling to attend school. The family noticed significant changes once Matthew transferred to Allegro School and began behavioral services at home. Now Matthew attends school regularly, takes the bus both ways with minimal challenges, and even participated in a recent school dance where he had a blast taking pictures with his mother and spending time



with his classmates. Matthew benefitted tremendously from Yahaira's relentless advocacy, as well as partnership with the school to link Matthew to behavioral supports. Behavioral services provided Matthew with much-needed support during his transitions back home from school, as well as increased support for community activities. As Matthew started feeling more comfortable in his community, he and his family became more connected. Matthew has attended the Tri County CMO picnic for the last three years and has been able to participate in school community outings without the same level of anxiety he experienced in the past.

Pride in Partnership

The Pioneer (formerly EmPoWER) Family Success Center (FSC) is a community-based, family centered, neighborhood gathering place where any Somerset County resident can go for family support, information, and referral to services. Tri County CMO supports the mission of the FSC to provide an environment to strengthen and empower individuals and families, and to build connections among families and the community. The FSC is conveniently located in downtown Somerville (50 Division Street).



Everything offered at the Pioneer Family Success Center is FREE. The bilingual staff at the FSC works collaboratively with various community partners to bring together resources and activities into an integrated services system. The FSC provides monthly Family Fun Nights, offers workshops/trainings in parent education and life skills, makes referrals and links families/individuals to county and local resources for food, clothing, housing, counseling, etc.

The twofold objective is: 1) to impart the role and wraparound care model of our agency as a DCF-Children's System of Care provider; and 2) elicit input from staff as to how we can collaboratively foster partnerships on behalf of our mutually served youth/student.
