### Youth Success Story



Olivia started her journey with TCCMO in May 2016, after more traditional therapeutic approaches failed to meet her needs. When a recommendation was made for Olivia to try yet another partial hospitalization program, her care manager Tina O'Sullivan and her intensive in-community therapist realized they had to do something to break the cycle. They advocated for Olivia to receive additional hours of in-home therapy and worked closely with Olivia and her family to identify positive community supports. With help from her team, Olivia learned to identify people and situations that triggered her to make poor decisions and made the tough choice to remove these triggers from her life. She began surrounding herself with more positive people, started going back to school, and found gainful employment in a retail setting, which allowed her to save enough money to purchase her first vehicle. With each positive choice she makes, she finds herself moving closer towards her dream of moving to



Vermont. Olivia attributes much of her success to her involvement with CMO, particularly her care manager Tina, whose outside-the-box thinking and relentless advocacy helped Olivia begin unlocking her potential to become the best person she could be. Olivia continues that journey into the New Year as she prepares to earn her diploma and continue working towards her dreams.



Tri County CMO consists of 72 staff dedicated to the agency's mission of utilizing Wraparound values to keep families strong. We pride ourselves on working as a team to get children and families the services they need for positive outcomes.

#### **Pride in Partnership**



Tri County CMO prides itself on surrounding families with a network of supports through collaborative relationships with a variety of system and community partners.

One of our closest partnerships is with the Family Support Organization (FSO). The caregiver of every child enrolled in TCCMO is eligible to work with a parent support partner to provide peer support, assist families in navigating service systems, provide information and advocate for the family's best interest.

The FSO offers parent support groups and educational workshops for parents as well as educational and supportive programming for youth through its Youth Partnership.

#### **Community Corner**

In 2004, the Annie E. Casey Foundation selected New Jersey to be among the first states to replicate the nationally recognized Juvenile Detention Alternatives Initiative (JDAI) to combat the overcrowding of NJ's detention facilities. In the years since, NJ has significantly decreased the number of youth in its detention facilities and created alternative options to incarceration while keeping juvenile crime rates low. Tri County CMO is proud to be a community stakeholder in JDAI in Somerset and Warren Counties. We are looking forward to the forthcoming implementation of JDAI in Hunterdon County and our continued efforts in upholding this key Initiative.
